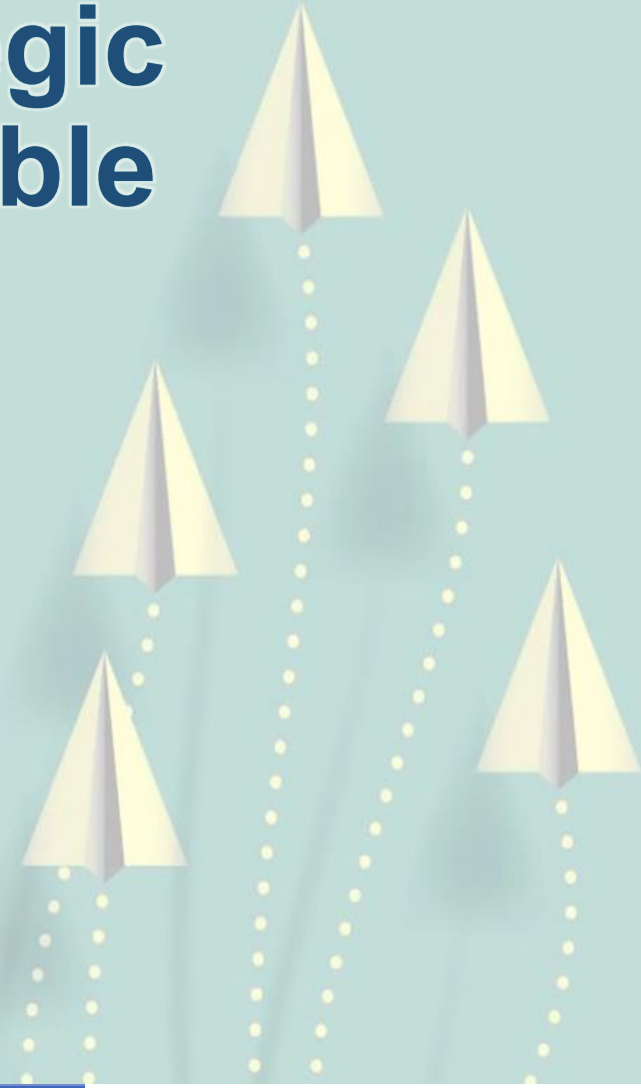

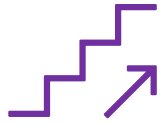
One to one sessions with officers from the Executive Officer Group (EOG).

Stakeholder Engagement Sessions – Examples



Explore and assess opportunities to improve standards within the PRS at a county wide scale, to address fuel poverty, living standards, and resident wellbeing.



Explore county wide incentives to increase the provision of affordable housing and social housing – to be based on evidenced need.



Sharing of best practice in areas aligned to the Vision e.g., retrofit of heritage properties – support learning and knowledge transfer.



Data capture to support in understanding the changing housing need across Oxfordshire.
