# 9. Land at Stockham Farm, Denchworth Road, Wantage. P12/V1240/FUL (Pages 6 - 21)

Residential development to provide 200 new homes across private and affordable tenures, with public open space and play space, the protection of the existing route of the Wilts and Berks Canal and the provision of land to allow for a realigned route, on-site car and cycle parking and improvements to site access and egress.

# 10. Land near to Shrivenham Football Club, Highworth Road, Shrivenham. P12/V1635FUL

Erection of 36 dwellings (comprising 10 open market, 12 for the over 55s age range and 14 affordable dwellings) with landscaping and associated infrastructure.

Change of use from public house (A4) with ancillary residential accommodation to a dwelling (C3) (without building work).
