10. Milton Road, Sutton Courtenay. P13/V0401/O

(Wards Affected: Sutton Courtenay and Appleford)
(Pages 9 - 32)

Demolition of no. 44 Milton Road to create access, residential development of site for up to 70 dwellings, including vehicular access, pedestrian and cycle links, public open space, landscaping and drainage.

Recommendation: It is recommended that the decision to grant planning permission be delegated to head of planning in consultation with the chairman and vice-chairman subject to:

- 1. Completion within the agreed planning performance agreement period of section 106 agreements for on-site affordable housing provision, on site open space provision, contributions towards off-site facilities and services including highways works, education improvements, waste management and collection, street names signs, public art, library and museum service, social and health care, fire and rescue, police equipment, local and area hub recreational and community facility improvements.
- 2. Conditions as outlined in the officer's report.

11. Land off Beggars Lane, Southmoor. P13/V0788/FUL

(Wards Affected: Kingston Bagpuize with Southmoor)

Erection of four detached dwelling houses with associated access.

Recommendation: Permission subject to the conditions set out in the officer's report.

12. St Helen & St Katharine School, Faringdon Road, Abingdon. P13/V0669/FUL

(Wards Affected: Abingdon Fitzharris)

(Pages 42 - 50)

Construction of new hard tennis/netball courts complete with fencing and lighting. Removal of existing hard courts and fencing: to be returned to grass.

Recommendation: Permission subject to the conditions set out in the officer's report.

13. Land at Town Pond Lane, Kingston Bagpuize with Southmoor. P13/V0606/FUL

(Wards Affected: Kingston Bagpuize with Southmoor) (Pages 51 - 61)

Erection of 2x3 bed chalet bungalows with detached garages and vehicular access (Resubmission of withdrawn application P12/02649/FUL).

Recommendation: that authority to grant planning permission is delegated to the head of planning in consultation with the committee chairman and vice-chairman subject to completing a section 106 agreement with the county council to secure contributions towards highway improvements, and to the conditions set out in the officer's report.
