Vale of White Horse District Council undertook a district wide review of parish arrangements in 2013/14 with Council agreeing changes at its meeting in July 2014. This committee undertook a number of further reviews, some deferred from the 2013/14 district wide review and others in response to further requests from parish councils, with any agreed changes implemented prior to the 2019 elections.

A community governance review (CGR) is a review carried out by a principal council of the whole or part of its area. The aim is to look at one or more of:

the creation, merging or abolition of parishes

- the naming of parishes
- the style of parishes (for example town, village, community)
- the electoral arrangements for parishes (for example size of parish councils, number of councillors, warding arrangements)

District council wards and county council divisions cannot be altered in a community governance order. However, a request may be made to the Local Government Boundary Commission for England to carry out a review for changes to district or county boundaries as a result of a local CGR.

At its meeting on 23 October 2017 this committee agreed "that the council undertakes a community governance review every four years with changes agreed for implementation at the next scheduled parish elections". In line with this resolution committee is invited to agree that a district wide community governance review is commenced in 2020.

#### **RECOMMENDATION:**

That officers submit a timetable for a community governance review to this committee for a review to commence in Spring 2020.

#### 52. Public participation

Councillor Emily Smith addressed the committee.

She spoke in support of the need for a designated polling place in polling district SAC2 (Harwell East) to serve the electorate in the Great Western Park development and requested that Harwell Parish Council is consulted on any venue.

She also stressed the need for a designated polling place in polling districts SSB1 and SSB2 (Segsbury ward of Wantage parish). She referred to anecdotal information that residents in this area had not voted in the recent Wantage and Grove County Division by election due to the distance needed to travel to The Beacon which was designated as a temporary polling place.

She also sought clarification regarding the recent changes to the boundary of Abingdon and neighbouring parishes and specifically where electors would vote if the parish and district ward boundaries were not coterminous (see minute 54).

Sarah Medley, a Harwell resident and Harwell parish councillor, addressed the committee on the need for a designated polling place in Harwell East to ensure the local electorate had a convenient location to vote (currently required to travel to Harwell village). She provided details of a possible location – Boundary Park Pavilion.

#### 53. Interim Review of Polling Districts and Polling Places

The committee considered the report of the head of legal and democratic on proposals for polling districts and polling places following an interim review in preparation for the May 2019 district and parish elections.

The committee considered the views expressed by Councillor Smith and Sarah Medley. In respect of polling districts SSB1 and SSB2, the committee agreed that officers should investigate the possible use of either King Alfred's School (west site) or Stockham Primary School. The committee noted the suggestion made by Sarah Medley in respect of Harwell East and requested officers investigate the suitability of the Boundary Park Pavilion as a polling place.

The committee further agreed that the final decision on the above matters should be made in consultation with committee members, the relevant local ward councillors and relevant parish council.

The committee supported the designations as set out in the schedule of polling districts and polling places attached as appendix A to the report subject to the above ongoing matters.

#### **RESOLVED:** to

- approve the schedule of polling districts and polling places set out in Appendix A to the report of the head of legal and democratic to the meeting of the Community Governance and Electoral Issues Committee on 26 November 2018 subject to 2 below;
- 2. authorise the returning officer, in consultation with committee members, relevant ward councillors and the relevant parish council, to allocate an appropriate polling place for polling districts SAC2 (Harwell East), SSB1 and SSB2 (Segsbury ward of Wantage parish).

#### 54. Request for related alterations - Community Governance Review of Vale of White Horse

The committee received a verbal update on the outcome of requests made to the Local Government Boundary Commission for England (LGBCE) to make changes to the boundaries of district wards and county divisions to reflect changes made at parish level following the community governance reviews completed in 2017 and 2018 and implemented on 1 November 2018 under the Vale of White Horse District Council (Reorganisation of Community Governance) Order 2018. Officers confirmed that at its meeting on 20 November the Commission had approved all the requests. The relevant Order will come into force for the May 2019 elections.

In response to the issue raised by Councillor Smith (see minute 52), officers confirmed that, due to the above, electors will now vote in the relevant Abingdon district and Abingdon parish ward.

The committee noted and welcomed the decision of the LGBCE which provided for coterminous district ward and parish boundaries for the benefit of the electorate.

## Polling District and Polling Places Review

#### Recommendation

That the Committee:

- 1. notes the consultation responses and the officer comments set out in appendix A;
- 2. notes the Acting Returning Officer's comments
- 3. approves the schedule of polling districts and polling places set out in Appendix C to this report
- 4. authorises the head of legal and democratic, acting in her capacity as the council's returning officer, to make changes to polling districts and polling places where circumstances dictate that this is desirable, having first consulted with members of the committee and the local councillor(s)

#### Purpose of Report

1. This report sets out proposals for polling districts and polling places following a periodic review required by the Electoral Registration and Administration Act 2013.

#### Strategic Objectives

2. The report does not specifically relate to any of the council's strategic objectives, but agreement of the recommendations (amended if the committee sees fit) will ensure compliance with the law.

#### Background

- 3. In accordance with the Electoral Registration and Administration Act 2013, the Council has a duty to undertake a review of parliamentary polling districts and polling places, which it must complete by the 31 January 2020. Subsequent reviews must be undertaken at least once every five years. The last such review in Vale of White Horse was undertaken in October 2014. The results of the polling districts and polling places review were agreed by this committee at its meeting on 27 January 2015. The council undertook an interim review with this committee agreeing recommendations at its meeting on 26 November 2018 prior to the district and parish elections in May 2019 to ensure arrangements reflected the outcome of recent community governance reviews agreed by this committee, reflected in the Vale of White Horse District Council (Reorganisation of Community Governance) Order 2018, and to ensure electors continue to have such reasonable facilities for voting as are practicable in the circumstances.
- 4. The current polling arrangements within the Vale are predominantly satisfactory as has been shown at elections conducted in recent years (the 2015 elections, the European Referendum, Police and Crime Commissioner elections in 2016 and the Oxfordshire County Council and Parliamentary elections in 2017) and very recently at the district and parish elections in May 2019, to be practicable. All polling stations were visited during the May elections and comments received have been taken into consideration as part of the review.

#### Terminology

- 5. **Polling District**: a geographical area created by the sub-division of a UK Parliamentary constituency or ward into smaller parts within which a polling place can be located which is convenient to electors. By and large each parish is a polling district in its own right and has its own polling place or places. Exceptions are where parishes are sub-divided into electoral wards or split between district wards which necessitates the creation of additional polling districts.
- 6. **Polling place:** the building(s) within each polling district that will house polling stations.
- 7. **Polling stations:** the room or area within the polling place where voting takes place. The number of polling stations within each polling place is a matter for the returning officer and is not covered in this report.

#### **Requirements of the review**

- 8. Local authorities must comply with the following legislative requirements when designating polling districts and polling places:
  - Each parish in England must be a separate polling district
  - The council must designate a polling place for each polling district
  - The polling place must be an area in the polling district unless special circumstances make it desirable to designate an area wholly or partly outside the polling district (for example, if no accessible polling place can be identified)

- The polling place must be small enough to indicate to electors in different parts of the district how they will be able to reach the polling station
- That so far as is reasonable and practicable every polling place is accessible to electors who are disabled

#### The review

8. Council gave notice of this review on 15 July 2019. Notice of the review was published on the council's website and given to the Acting Returning Officer (ARO), parish councils, district councillors and members of parliament. The review was also publicised via a press release and social media. The Acting Returning Officer for Oxford West and Abingdon and Wantage was consulted and her comments are attached at appendix one.

#### **Consultation responses**

9. The council received a number of responses before the deadline of 27 September which are set out in appendix A attached to this report with officer comments. The Acting Returning Officer for Oxford West and Abingdon and Wantage was consulted and her comments are attached at appendix B and referred to below.

#### Key issues

- 10. Due to renovation works, St Mary's Convent was not available as a polling place for the elections in May 2019. This committee designated Stockham School as the alternative polling place for those elections and the same venue was used at the European parliamentary elections. This arrangement was not supported by the school and did not provide a suitable location for polling station staff or electors. In her comments, the ARO, also asked the council to endeavour not to use schools that are required to close if used as a polling station. Officers will continue to seek an alternative venue and will assess the suitability of St Mary's Convent as a polling place following the renovation works. In the meantime, officers propose that The Beacon is designated as the polling place for polling districts SSB1 and SSB2 (covering the Segsbury ward of Wantage parish). The most impacted electors will have to travel an additional distance of approximately 0.5 miles vote at The Beacon.
  - 11. In her comments the ARO suggests no polling place is shared by two district wards, unless special circumstances apply, such as the lack of a suitable building for polling stations in the adjoining areas, to avoid potential confusion for voters. Where this is not avoidable or is considered to offer geographical convenience to voters, she recommends the use of separate rooms or a physical boundary should be considered. The election team welcome this suggestion and will ensure a clear physical barrier is provided in such circumstances.
  - 12. Officers are also currently identifying alternative polling places for those designated in appendix C should any become unavailable for a particular election.

#### **Financial Implications**

13. There is a modest cost associated with running a polling place. Often this cost is shared amongst a number of parties because the polling place hosts multiple elections at the same time. At national elections the cost is reimbursed to the council. Cost, however, should not be a consideration in determining how many polling places to designate

#### Legal Implications

14. The Electoral Registration and Administration Act 2013 requires the council to complete its review of polling districts and polling places by 31 January 2020. Decisions made in respect of the proposals in this report will fulfil this requirement.

#### Risks

15. There are no discernable risks associated with the proposals set out in this report

#### Conclusion

16. The council has a legal requirement to complete a review of polling districts and polling places by the end of January 2020. Decisions taken in respect of this report will fulfil that requirement.

#### VALE OF WHITE HORSE DISTRICT COUNCIL REVIEW OF POLLING DISTRICTS AND POLLING PLACES 2019

#### COMMENTS FROM THE ACTING RETURNING OFFICER

This sets out the Acting Returning Officer's (ARO) submission to the above review.

The ARO is responsible for the conduct of the elections for two Parliamentary Constituencies which cover parts of Vale of White Horse District Council – namely Oxford West and Abingdon and Wantage. The boundaries of those constituencies extend to also cover part of Oxford City and Cherwell (for Oxford West and Abingdon) and South Oxfordshire (for Wantage).

The following comments concentrate solely on the polling districts and polling places which are located within Vale of White Horse District Council.

The council undertook an interim review in 2018 in preparation for the district and parish council elections in May 2019. There have been very few adverse comments from voters, political parties or polling station staff about the polling places used. Consequently, I am content with the current designations, which on the whole have been in place for the District, County, Police and Crime Commissioner, Parliamentary and European elections in the past four years. In general terms, all the buildings used as polling stations are considered to be fit for purpose, accessible to the majority of the electorate which the venue serves, and accessible for those with a disability.

Because of recent community governance reviews the council has adjusted some parish boundaries and proposed, and received consent, to make related alterations to district ward and county division boundaries. These changes have resulted to changes to some polling districts at parish level to reflect the changes.

The table available on the <u>council's website</u> sets out the name of each polling district and the polling place used. It also shows where a polling place is outside a polling district. As stated, I am content with the current arrangements but do have a few observations set out below:

- Where possible I suggest that the council should identify an alternative polling place for that designated in case it is not available for a particular election.
- Attempts are made not to use schools for polling places as, understandably, head teachers and parents do not welcome either the disruption of closing the whole school for a day or the security issues if a room is used as a polling place and the remainder of the school remains open. The council designated Stockham Primary School as a polling place for polling districts SSB1 and SSB2 due to renovation works to the previous polling place at St Mary's Convent. I would urge the council to seek an alternative venue to avoid the use of Stockham Primary School. The council currently designates St Blaise CE Primary School as a polling place for polling district SJD. I would ask that

the council reviews the implications of this on the school and, if necessary, seek an alternative venue.

• I suggest no polling place is shared by two district wards, unless special circumstances apply, such as the lack of a suitable building for polling stations in the adjoining areas, to avoid potential confusion for voters. Where this is not avoidable or is considered to offer geographical convenience to voters, the use of separate rooms or a physical boundary should be considered.

I will continue to monitor developments in respect of the major residential developments in the Vale and make recommendations to change polling districts and polling places as required.

I reserve the right to make further comments after the close of the public consultation period.
