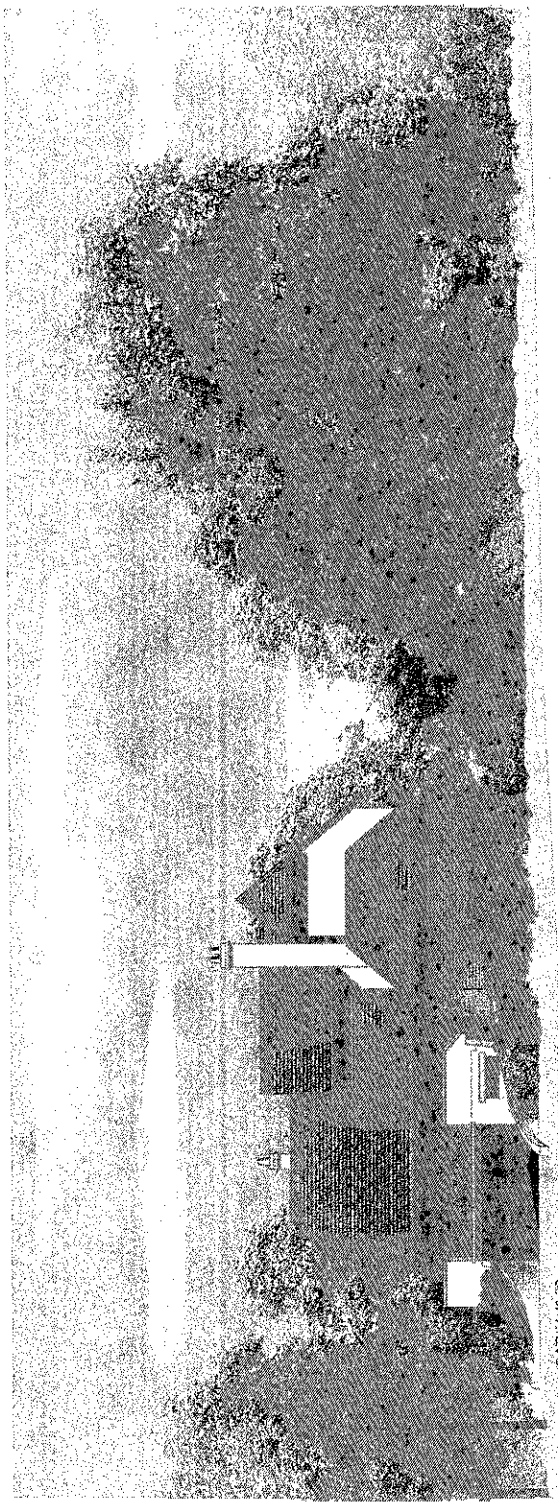

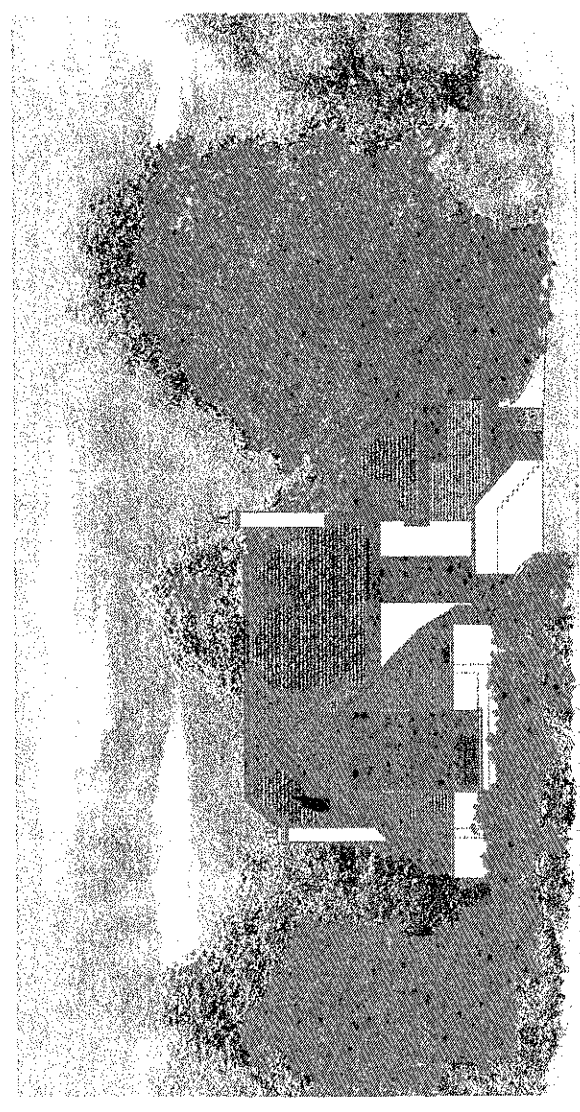
LOWER GROUND FLOOR PLAN

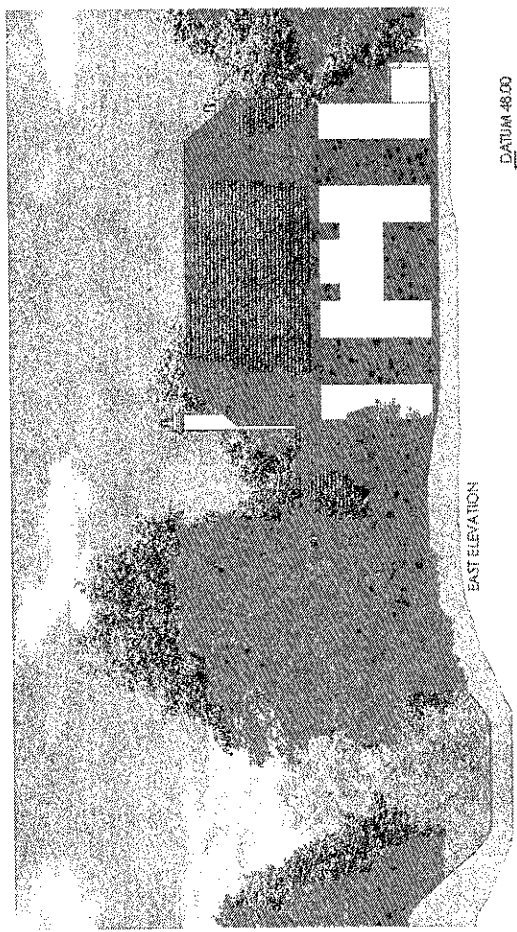
