## **CUMULATIVE HOUSING FIGURES**

At the meeting on 7 November 2012, planning committee requested the inclusion in committee reports of an update of housing figures relating to commitments (i.e. resolutions to grant permission and permissions) for major housing schemes to help address the council's housing land shortfall. These figures do not form part of the individual assessment of any submitted application, which need to be assessed on the basis of each scheme's specific planning merit, but they offer an indication of how the shortfall is being addressed. Each planning permission for these schemes is granted on the basis of a one year implementation period only, to ensure the development is initiated and so help to reduce the housing land shortfall. The current commitments are shown in the table below.
