Purpose of Report

1. The purpose of this report is for the committee to note the update of previously funded projects attached at appendix one of this report.

2. The council has a corporate priority to offer support to local communities by offering grants to voluntary and community organisations who are delivering projects and services that support it's own objectives or those in need.

Background

3. The committee determined the awards detailed at appendix one of this report at meetings on 3 December 2012 (2012/13) and 22 April 2013 (2013/14).

Financial Implications

4. The budget for 2012/13 was £29,904 the committee allocated £23,150 in December 2012 leaving a remainder of £6,754 that was then carried forward to the 2013/14 budget of £29,904 making a total of £36,658 to allocate during this financial year.

- 5. The committee awarded £14,808 in April 2013 during the first round of funding and an update of these awards is attached at appendix one.
- 6. The remaining balance available for the next round of funding is therefore £23,840 (this includes £1,990 returned to the budget from completed 2012/13 projects that under spent).
