Dear Sir / Madam

Please see previous correspondence below between my wife and your Environmental Health team concerning noise disturbance caused to us by events at Kingston Bagpuize House. What we hear is not necessarily loud; what we usually hear is thumping bassline, or more depending on wind direction, which makes it impossible to sleep before midnight with windows open or sit peacefully in our garden.

The blue line on the OS map extract below indicates the distance of only 400 metres as the crow flies between the usual position of events marquees at KB House and our property.


It is wrong that the financial gain of the Applicant is able to ruin the peace and relaxation of many others in this way.

Other more immediate neighbours, being tenants of the Applicant, may be afraid to voice their objection.

We particularly object to the application being for the lengthy period 15.00 – 00.00 on Friday and Saturday and we specifically object to the idea that we might be subjected to this nuisance at <u>any</u> time on a Sunday, let alone right up until midnight and (on one occasion) until 03.00.

We have heard various suggestions anecdotally that they are supposed to use "acoustically lined marquees" and are obliged to "control the volume" – If these are in fact true, I would contend they achieve little or nothing.

We also express concern about the area within the grounds of KB House that may be used for such events, since the boundary of their land is only 110m from our property
