# Appointments to committees, panels and joint committees 2015/16

#### Recommendations

#### That Council:

- agrees to establish a joint Scrutiny Committee with South Oxfordshire District Council with the terms of reference and administrative arrangements as set out in this report;
- 2. agrees to establish a joint Audit and Governance Committee with South Oxfordshire District Council with terms of reference and administrative arrangements as set out in this report.
- 3. appoints the committees and panels for the 2015/16 year, allocates seats to each political group and appoints councillors and substitutes to sit on them in accordance with paragraphs 8-10 of this report and as set out in the schedule circulated at the meeting;
- 4. appoints chairmen and vice-chairmen as set out in the schedule circulated at the meeting;
- 5. appoints three area committees for the 2015/16 municipal year, agrees the geographical area of each area committee together with the total number of area committee as set out on the map attached to the report and appoints all local members representing the wards covered by each relevant area:
- appoints councillors to the Licensing Acts Committee in accordance with paragraphs 23-25 of this report and as set out in the schedule circulated at the meeting;
- 7. appoints a representative and a substitute on the Oxfordshire Joint Health Overview and Scrutiny Committee;
- 8. appoints a representative and an observer substitute on the Thames Valley Police and Crime Panel;
- authorises the head of legal and democratic services to make appointments to any vacant committee or panel seat and substitute positions in accordance with the wishes of the relevant group leader;

10. authorises the head of legal and democratic services to amend the constitution as necessary to reflect the arrangements set out in this report.

## **Purpose of report**

1. This report invites Council to agree appointments to those committees required to be politically balanced together with the area committees and the Licensing Acts Committee. It also invites Council to make appointments to joint bodies.

## **Background**

- 2. The Council is required by the Local Government and Housing Act 1989 to appoint committees, review the political balance and to appoint councillors to the committees annually.
- 3. In summary the Council has a duty to ensure the following principles are adhered to:
  - (i) not all seats are allocated to the same political group
  - (ii) a majority group should get the majority of seats on each committee
  - (iii) the seats allocated to groups on a committee reflect the membership of the Council as a whole
  - (iv) the allocation of the total number of seats on all committees reflects the membership as a whole
- 4. Ordinary committees are those that have decision-making powers but excluding the Licensing Acts Committee.

## **Strategic Objectives**

5. This report supports the council's corporate plan in that it ensures the council manages its business effectively. It is also in line with the council's requirement to review the political complexion of committees and other bodies, having regards to the Local Government and Housing Act 1989.

#### Political balance

6. The number of seats held by the various political groups is currently as follows:

Conservative 29 (76.32%) Liberal Democrat 9 (23.68%)

7. The Local Government (Committees and Political Groups) Regulations 1990 require a constituted political group to be two or more members.

## **Composition of committees**

8. The ordinary committees and panels that are required to be politically balanced both individually, and overall, are set out below.

- Scrutiny, Planning and the Community Governance and Electoral Issues committees have been reduced by 25% from the previous civic year. This reflects the 25% reduction in councillors.
- General Licensing Committee has decreased to 12 members on the same basis.
  The membership of this and the Licensing Acts Committee are the same,
  although they are two separate entities. This allows for a sufficiently large, well
  trained pool of councillors from which to draw the General Licensing and
  Licensing Acts Panels, and avoids confusion as to which members are on which
  committee. These committees may appoint the same, or different chairmen and
  vice chairmen.
- The Joint Audit and Governance Committee and Scrutiny Committee must have a total membership that is even to allow for a split between the councils.
- 9. The terms of reference of the committees and panels are set out in the constitution and in subsequent agreed council minutes. No changes are proposed to existing committees.
- 10. The political balance calculation and the entitlements to seats on committees are set out in the tables below. Fractional entitlements of less than one half are rounded down and entitlements of one half or more are rounded up.

11. If the Council wishes to allocate any seats not in accordance with the political balance requirements it can only do so if no councillor votes against the proposal.

#### **Substitutes**

12. Any member of a group may substitute for another member of their group on scrutiny, joint scrutiny, joint audit and governance and community governance and electoral issues committees. Appropriately trained group members may substitute for other members of their group on planning and general licensing committees.

## **Joint Scrutiny Committee**

- 13. Council is invited to consider the establishment of a joint scrutiny committee to meet at least twice a year to review a number of standing items that affect both councils as set out below:
  - Performance reviews of joint contracts
  - Other issues that affect both councils jointly
- 14. Joint Scrutiny may meet on additional occasions if the need arises.
- 15. The purpose of a joint scrutiny committee is to ensure a consistent approach, avoid duplication of resources and improve joint working between both councils. This committee will only seek to address matters which are being progressed across both councils.
- 16. The creation of a joint scrutiny committee meeting initially twice a year, with an option of increasing joint meetings as we go forward, would reduce the number of reports being written and the number of evening meetings staff have to attend and would enable contractors to attend just one meeting a year. Running joint meetings in addition to those already scheduled at each council would have

- resource implications in terms of staff capacity. Officers therefore propose a reduction in the number of Vale scrutiny committee meetings by two.
- 17. The information below sets out the proposed membership of the joint committee, arrangements for the location and regularity of meetings, the proposed chairing arrangements and the proposed terms of reference.

#### Membership

- Five councillors from Vale of White Horse District Council (not Cabinet members); and
- Five councillors from South Oxfordshire District Council (not Cabinet members).
- Politically balanced in accordance with the provisions of the Local Government and Housing Act 1989. (Politically balanced by council, not necessarily across both councils).
- Substitutes from the political groups (not Cabinet members).

#### Quorum

Four members, two from each council.

#### Regularity of meetings

At least two per year, with additional meetings on an ad hoc basis.

**Location of meetings:** At the councils' offices in Milton Park.

#### Chairmanship

 The committee will be co-chaired (one from each council) and the person presiding at any meeting will alternate between the two councils. These shall be non ruling group and non Cabinet members and their will be no vice chair.

#### Terms of reference

- to monitor the performance of contractors delivering joint contracts;
- to consider any matter affecting both areas or their inhabitants jointly (subject to the agreement of the chairmen of each council's scrutiny committee).

The establishment of a joint scrutiny committee will not impact upon the ability of each council's scrutiny committee to review specific issues covered by the above terms of reference – for example a specific issue relating to a contract.

#### **Scrutiny Call-in**

The right to call in decisions, in line with the council's constitution, will remain with the district Scrutiny Committee, but the chairman of this committee may choose to refer it to the joint committee.

If agreed officers will make the necessary changes to the council's constitution to reflect the above.

#### **Joint Audit and Governance Committee**

- 18. Council is invited to consider the establishment of a joint audit and governance committee. This will replace the individual committees at Vale of White Horse and South Oxfordshire district councils and will meet four times a year. Matters which only affect one council will be dealt with by sub-committees which are set out below.
- 19. The purpose of a joint audit and governance committee is to ensure a consistent approach, avoid duplication of resources and improve joint working between both councils. This committee will only seek to address matters which are being progressed across both councils.
- 20. This will reduce the number of reports being written and the number of evening meetings staff have to attend and would enable the district auditors to attend just one meeting. Running joint meetings in addition to those already scheduled at each council would have resource implications in terms of staff capacity. The information below sets out the proposed membership of the joint committee, arrangements for the location and regularity of meetings, the proposed chairmanship arrangements and the proposed terms of reference.

#### Membership

- Four councillors from Vale of White Horse District Council (not Cabinet members) and
- Four councillors from South Oxfordshire District Council (not Cabinet members).
- Politically balanced in accordance with the provisions of the Local Government and Housing Act 1989. (Politically balanced by council, not necessarily across both councils).
- Substitutes from the political groups (not Cabinet members).

#### Quorum

Four members, two from each council.

#### Regularity of meetings

At least four per year

#### **Location of meetings**

At the Council's offices in Milton Park.

#### Chairmanship

The committee will be co-chaired (one from each council) and the person presiding at any meeting will alternate between the two councils. These shall be non Cabinet members and their will be no vice chair.

#### **Sub Committees**

These shall meet as required to discuss and agree matters relating to a single council. They will not discuss matters which go to the joint committee. They will be chaired by the co-chair of the joint committee and the membership shall be the four members of the joint committee relevant to each council. Quorum will be three.

#### Terms of reference

The terms of reference will be drawn from those of the existing Audit and (Corporate) Governance committees of the two councils.

If agreed officers will make the necessary changes to the council's constitution to reflect the above.

#### **Area Committees**

- 21. In 2003, the Council established area committees with the terms of reference set out in the council's constitution. In January 2011 the Executive delegated the award of community grants to the area committees. The area committees consist of councillors for the relevant area only. Council is invited to confirm the membership of the area committees for the next municipal year as those local members representing those areas. The Council is asked to note that the area committees do not need to be politically balanced and, therefore, the area committees are not included in the calculation of seats to political groups. Council is requested to appoint councillors to the area committees as set out in the schedule circulated at the meeting.
- 22. Council is invited to reset the geographical boundaries of the area committees following the changes to the council's ward boundaries and the reduction in the total number of councillors, this to include reducing the number of committees to three, based around the three market towns of Abingdon, Wantage and Faringdon. The attached map shows details of the boundaries.

## **Licensing Acts Committees**

- 23. The Licensing Acts Committee is a statutory committee and is not required to be included in the calculation of political balance. The committee meets rarely to deal with licensing and gambling policy matters but a membership of 12 provides a pool of councillors from which panels of three can be drawn to deal with hearings relating to personal licence holders and premises licence applications and reviews.
- 24. Council has previously agreed to appoint a committee in accordance with the political balance of the Council. The membership will mirror the membership of the General Licensing Committee and will, therefore, be politically balanced but will not in itself contribute to the total political balance of the council's committees.
- 25. As a statutory committee with a specified membership substitutes may not be appointed.

## Location of all meetings

26. Meetings of full Council, Planning Committee, Vale Scrutiny Committee and area committees will take place at The Beacon. All other meetings of the council and joint committees will take place at the councils' offices in Milton Park. This will optimise the use of officer time.

## **Appointments**

27. Officers have invited group leaders to submit the names of councillors they wish to sit on each of the above bodies. A table of nominations will be circulated at the meeting.

## **Joint Health Overview and Scrutiny Committee**

28. Council is invited to appoint a representative and a named substitute to the Oxfordshire Joint Health Overview and Scrutiny Committee.

## Thames Valley Police and Crime Panel

29. Council is invited to appoint a representative to the Thames Valley Police and Crime Panel. The constitution of the panel does not provide for formally appointed substitutes but Council may appoint one in an observer capacity.

## Financial implications

30. There are no direct financial implications.

## Legal implications

31. These are set out in the body of the report.

#### Conclusion

32. In deciding the committees and panels it wishes to establish for the 2015/16 year, Council is required to allocate seats to political groups in the same proportion as they hold on the council as a whole. Against that background, Council is invited to establish the committees and panels set out in the table in paragraph 8 of this report and to appoint councillors to them. Council is also invited to appoint councillors to the area committees and the Licensing Acts Committee and to appoint representatives to the Oxfordshire Joint Health Overview and Scrutiny Committee and the Thames Valley Police and Crime Panel. If all committee and panel seats and substitute places are not filled at the meeting, Council is invited to delegate authority to the head of legal and democratic services to make appointments in accordance with the wishes of the relevant group leader. Council is also invited to delegate authority to the head of legal and democratic services to amend the constitution accordingly.
