Recommendation(s)

To: Recommend that Council makes the Great Coxwell Neighbourhood Plan part of the Development Plan for the Vale of the White Horse.

Purpose of Report

 To agree the Adoption of the Great Coxwell Neighbourhood Planning Area as a part of the Development Plan.

2. Background

- 1. The Neighbourhood Plan has followed the correct statutory process and this is the final step in its development.
- 2. Great Coxwell Neighbourhood Plan was agreed through a local referendum in March 2015. The next step in the process is to consider making the Plan a part of the Development Plan for the Vale of White Horse and to recommend to Full Council that the Great Coxwell Neighbourhood Plan be adopted as a part of the Development Plan.
- Once adopted the Great Coxwell NDP will form part of the statutory development plan for the district. Its policies will be relevant for the determination of planning applications in the parish.

Reasons for decision	The Neighbourhood Plan has followed the correct statutory process and this is the final step in its development.		
	Great Coxwell Neighbourhood Plan was agreed through a local referendum in March 2015. The next step in the process is to consider making the Plan a part of the Development Plan for the Vale of White Horse and to recommend to Full Council that the Great Coxwell Neighbourhood Plan be adopted as a part of the Development Plan.		
Alternative options rejected	The Neighbourhood Plan now has significant weight in Planning Policy terms. Under Section 61E(8) of the Localism Act, the District Council only have an option not to 'make' the plan where they consider it would breach, or otherwise be incompatible with, any EU obligations or any of the Convention rights (within the meaning of the Human Rights Act 2998). These considerations do not apply so no alternative options have been considered.		
Legal implications	Once adopted the Great Coxwell NDP would form part of the statutory development plan for the district. Its policies would be relevant for the determination of planning applications in Great Coxwell parish.

Guidance notes

- Once satisfied with the decision, the Cabinet member must sign and date the form and return it to the lead officer who should send it to Democratic Services immediately to allow the call-in period to commence. - 3. Democratic Services will then publish the decision to the website (unless it is confidential) and send it to Scrutiny Committee members to commence the call-in period (five clear working days). The decision cannot be implemented until the call-in period expires. The call-in procedure can be found in the council's constitution, part 4, under the Scrutiny Committee procedure rules.
- 4. Before implementing the decision, the lead officer is responsible for checking with Democratic Services that the decision has not been called in.
- 5. If the decision has been called in, Democratic Services will notify the lead officer and decision-maker. This call-in puts the decision on hold.
- 6. Democratic Services will liaise with the Scrutiny Committee chairman over the date of the call-in debate. The Cabinet member (the decision maker) will be requested to attend the Scrutiny Committee meeting to answer the committee's questions.
- 7. The Scrutiny Committee may:
 - · refer the decision back to the Cabinet member for reconsideration or
 - refer the matter to Council with an alternative set of proposals (where the final decision rests with full Council) or
 - accept the Cabinet member's decision, in which case it can be implemented immediately.
