# Statement of Community Involvement

### Recommendation(s)

- 1. The committee is invited to:
  - comment upon the draft Statement of Community Involvement (SCI)
  - make recommendations to the cabinet member for planning policy for any alterations to the draft SCI document prior to approval of publication by Cabinet on 2 December 2016.

# **Purpose of Report**

 To report to Scrutiny Committee the key issues raised following the eight week public consultation and the changes proposed to the Statement of Community Involvement (SCI) document.

# **Strategic Objectives**

2. The publication of the SCI supports the delivery of the Council's strategic objectives by supporting the delivery of sustainable communities and wellbeing.

# **Background**

- 3. The Council is required to produce a SCI in accordance with section 18 of the Planning and Compulsory Purchase Act 2004. The purpose of the SCI is to set out how the council will engage with communities who have an interest in matters relating to development in their areas.
- 4. The original SCI was adopted in December 2009, is now out of date and for this reason has been reviewed to reflect changes to legislation, national policy e.g.

- National Planning Policy Framework and the National Planning Practice Guidance and the council's working practices.
- 5. Scrutiny Committee will recall that a draft SCI was published, alongside the Local Plan 2031 Part 1 Main Modifications, for public consultation for a period of eight weeks.
- 6. The new SCI document comprises of three parts that will assist interested parties who wish to be involved in the planning process:
  - Part 1 Getting Involved in Shaping our Future.
  - Part 2 Getting Involved in the Local Plan and Planning Policy.
  - Part 3 Getting Involved in Planning Applications.
- 7. Once adopted, the council will use the document when preparing and consulting on new planning documents, and to assist in deciding on planning applications for development.

#### Key discussion points raised following public consultation

- 8. Public consultation on the draft SCI was undertaken for a period of eight weeks from 20 July to 14 September 2016.
- 9. The consultation received a total of 5 representations from 5 individual consultees.
- 10. During this period, the draft SCI consultation document was taken to Scrutiny Committee on 28 July 2016. The SCI was well received by the committee, with particular support for the content, structure, format and presentation of the document. It was agreed that the use of flow charts and diagrams will provide useful clarity for the wider audience in understanding the planning process.
- 11. Scrutiny Committee made a number of comments to help refine the SCI document. These included:
  - the use of a Development Forum in the pre application process should be revisited in the SCI to provide further clarity
  - a glossary of terms should be added to each part of the SCI document
  - all footnotes should be on the relevant page rather than at the end of the document, and
  - a separate section should be included in Part 2 of the SCI that contains information on neighbourhood plans
- 12. Other comments were received at Scrutiny and where appropriate, they have helped to refine the final version. It was considered that the changes were necessary to provide further clarity and consistency for the wider audience.
- 13. Other issues were raised during the consultation from consultees. The main issues included:
  - the use of Development Forums in the context of planning applications for major proposals
  - the need to publicise comments following the consultation on a planning policy document, and

- the need to clarify the roles and responsibilities of Oxfordshire County Council (OCC) in the planning process.
- 14. Statutory organisations, including OCC and Natural England, were supportive of Part 1 of the SCI in setting out the principles for meaningful and early engagement on local planning matters to shape policy and in the process of determining planning applications.
- 15. OCC commented that further improvements should be made to the wording in Part 2 to clarify their role and responsibility for preparing up to date minerals and waste planning policies and proposals. OCC also requested further reference made to their Neighbourhood Planning Toolkit.
- 16. A few comments were made on Part 3 of the document. For example, Bellway Homes Ltd objected to the use of Development Forums for all major planning applications as they consider it affects the delivery of their projects.
- 17. OCC commented that a reference should be made in Part 3 to the other types of planning applications that are not dealt with by the Council.
- 18. A full summary of the comments received during the consultation, along with the officer response, is available at **Appendix 1**.

#### **Refinements to the Statement of Community Involvement**

- 19. The draft SCI has been refined, taking into account the comments made during the consultation. The finalised version is presented as a track change document Appendix 2. This should be read alongside Appendix 1, which provides the justification for making any necessary changes to the document.
- 20. The format and presentation of this document will remain consistent with the draft document published for consultation in July 2016.
- 21. The main changes to the whole SCI document Parts 1 3 include the addition of a glossary at the end of each part explaining any key planning terms used.

#### Part 1 – Getting Involved in Shaping our Future

22. There is a change made to Part 1 of the SCI to take into account the recommendation following the recent Audit on the Botley Centre Supplementary Planning Document. This change is deemed necessary in identifying the responsible officer and/or team for a consultation on planning policy or a planning application.

# Part 2 - Getting Involved in the Local Plan and Planning Policy

- 23. Changes are made to Parts 2 and 3 of the SCI to take into account further recommendations from the Audit Report. For example, the SCI now includes how the council will acknowledge responses made towards planning policy consultations and for consultations on planning applications.
- 24. The document also includes information on how and where parties can view other comments made during the consultation. This reflects comments made by OCC.

- 25. Regarding neighbourhood planning, a change was made to include information on neighbourhood plans in a separate section of Part 2. This sections also takes into account the emerging Neighbourhood Planning Bill by setting out the council's role in neighbourhood planning, including a 'duty to support' qualifying bodies at the key stages of preparation.
- 26. A change has been made in this section to reflect a comment made from OCC to consider how they can offer further support to communities preparing a neighbourhood plan. This section now includes a reference to their Neighbourhood Planning Toolkit.

#### Part 3 – Getting Involved in Planning Applications

27. The main change to Part 3 of the SCI is a modification to the supporting text for Development Forums. This change is necessary to provide further clarity and consistency of their role during the pre – application process. The SCI now explains the purpose and benefit of a Development Forum, while stating that it is an optional part of the pre – application process. This reflects the comments made by Bellway Homes Ltd.

#### **Financial Implications**

28. There will be costs associated with the printing and distribution of the SCI document.

#### **Legal Implications**

29. The council is legally required, under section 18 of the Planning and Compulsory Purchase Act 2004, to produce an SCI to set out how we will engage with our communities who have an interest in matters relating to development in their area.

#### **Risks**

30. Not applicable

#### Conclusion

31. The SCI will be a vital tool to assist the Council in the preparation of planning policy documents and when deciding on planning applications for development. The changes made following public consultation, will provide further clarity to the community, developers, development management team, town and parishes and councillors who may wish to be involved in the planning process.
