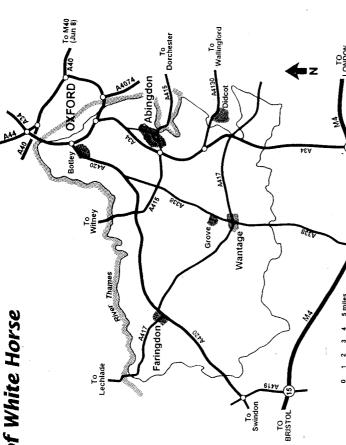

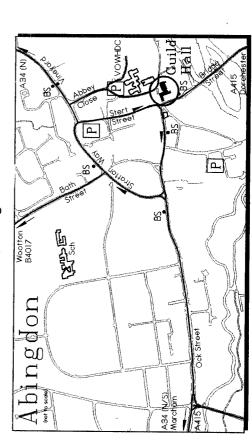

Bill Proctor made a statement seeking support for the application commenting on how disabled people had to be carried into the boats. He reported that the proposal would enable better access for sailors, their carers and families. He explained that the water level could drop significantly and therefore the proposal incorporated an electric lift for use when the ramps could not be used safely. There would be an increased harbour area which would enable increased use. He reported that the scheme was divided into phases and he explained the shortfall in the funding required.

The Chair thanked Bill Proctor for his statement advising that it would be taken into account by members when they considered the application later in the meeting.

## Ab.11 <u>PROGRESS REPORT ON THE VALE PARTNERSHIP AND THE OXFORDSHIRE LOCAL AREA AGREEMENT</u>

The Committee received and considered report 38/07 of the Strategic Director and Monitoring Officer which advised that following the publication of the White Paper on the Future of Local Government ('Strong & Prosperous Communities') in the autumn of 2007, the Vale Partnership Board (comprising the District Council and key agencies to influence quality of life in the Vale) had commenced a review of the Vale Community Strategy 2004-2008. The Oxfordshire Partnership had also commenced a review of the Oxfordshire Community Strategy, in preparation for negotiations with central government on the priorities and targets in the next Oxfordshire Local Area Agreement.

The report provided further information on the reviews of the Vale Community Strategy and the Oxfordshire Community Strategy and also gave an opportunity for Members to provide information in respect of the social issues and priorities for the Abingdon area.

One Member made reference to climate change. He noted that whilst climate change was mentioned in the matrix, he considered that it should be given more emphasis and should be specific to areas. He considered that climate change should be incorporated into the Core Strategy.

Another Member welcomed the report noting that there were some minor typographic errors. The Officers responded that the document was a working document and would be redrafted for public consultation.

One Member emphasised the need for measurability and reporting back. She referred to the example of teaching English as a foreign language and questioned who would provide the teaching, who would monitor it, who was it aimed at, what were the benefits and how would these be measured. She stated that there needed to be achievable, realistic and measurable targets with reporting back being included.

Some Members commented that they required further time to read the report and submit their comments on the Strategic Matrix to the Head of Community Strategy outside of the meeting.

Background Papers: Grant applications and correspondence from applicants

(i) Applicant: Dorchester Sailing Club, based in Abingdon Road, Dorchester

Years in existence: 49 Years

**Type of organisation:** Not for profit company limited by guarantee, now registered as a Community Amateur Sports Club (CASC). This is a scheme recognised by the Inland Revenue which allows amateur sports clubs 80% mandatory rate relief, gift aid on donations and exemption from some levels of corporation tax. In order to register clubs have to comply with certain criteria including having a constitution which requires that profits from the club go back to the club and that membership is open to the whole community.

**Project, service or event details:** Dorchester Sailing Club is seeking a grant towards the cost of building a new clubhouse which will provide changing and showering areas, toilets, a kitchen, a dining and social area, disabled facilities and a club and training room with a hearing loop. The existing building, which reached the end of its life some years ago, will be converted to a secure workshop and storage location. The new unit will be a modern 'fit for purpose' onshore facility to support the continuation and development of a fuller and wider range of year-round activities for all the local community especially for the disabled, children and young people in the community.

Dorchester Sailing Club is the only club in the south of Oxfordshire which offers year round water sports. Other organisations will be encouraged to use the facilities when not required to support sailing and related activities, for example a Bridge Club has already expressed an interest in hiring the new facilities. These open facilities will be of particular interest to residents in Abingdon and the surrounding villages. The club has 190 family members and, if the relatives who are active from time to time are included, this rises to 320.

The club is the only local club recognised by the Royal Yachting Association (RYA) as an "On Board" club. This is due to its commitment to widening access, through water sports, to an active lifestyle for young people through school and youth group links. "On Board" relates directly to the Government's Physical Education School Sports Club Links initiative and to the Department of Culture, Media and Sports Public Service Agreements with Sport England. The club works to agreed set targets for levels of initial introduction to the sport and ongoing participation. It aims to reach out to disadvantaged teenagers in the Vale (and South Oxfordshire) through this scheme.

The District Council's Sports Development Officers were very pleased to be able to use Dorchester Sailing Club's facilities at short notice for their summer canoeing activities when Abingdon marina became unavailable due to the flooding.

Although the RYA does not directly provide capital funding for large projects, the club receives some revenue funding on a "matched" basis and low cost access to training courses for its volunteers.

**Supports following Vale Community Strategy strands:** Access to Services, Recreation, Culture & Leisure, Safe & Supportive Communities, Town & Village Vitality, Environment, Health & Wellbeing

Area of the Vale covered and estimate of number of people the project/service/event will benefit: The club is open to everyone in the Vale who is interested in watersports; in addition the new club-house will be available for hire to everyone in the Vale, although the

benefits of both will primarily be felt in Abingdon and the surrounding villages. Abingdon Sea Scouts use the facilities on a regular basis.

Estimate of number of people the project/service/event will benefit: Around 35% of the current membership lives in the Vale.

Charge to public for using the project/service/event?: Joining fee £60.00, Family Membership £100.00 pa, Boat usage/storage £49 pa. Special arrangements for OAPs, disadvantaged adults and young people.

**Total estimated project cost:** £212,729.00 excl VAT; £249,957.00 inc. VAT (VAT may be reclaimed)

#### Applicant: Compass Café, based at the Peachcroft Christian Centre, Abingdon (ii)

Years in existence: 5 years as Eclipse Café, reopened in new building as Compass Café April 2007.

Type of organisation: Youth Club.

Project, service or event details: Compass Café is seeking a grant towards employing a part-time youth worker to enable the Café to extend its activities to 16-19 year olds twice a month. Two local police officers have promised to help run these sessions. A group of 16-19 year olds, who are in regular contact with local police, are known to be involved in anti-social behaviour. The part-time trained youth worker would keep in regular contact with these young people and be able to offer advice, friendship and support to 11-19 year olds when needed outside the Café opening hours, as well as help to run the Café.

Currently Compass Café runs every Wednesday evening for 11-16 year olds providing a venue to meet, play games, watch films on a big screen and participate in other activities when arranged, such as dance and DJ workshops. It is the only evening venue open in North East Abingdon which offers something for teenagers to do. A number of teenagers who attend Compass Café have difficulties with school and a couple are excluded from school.

This grant would be supported by some limited existing funds. The Café aims to advertise the post soon with a view to employment starting on 1 January 2008 for one year. It is hoped that the church and other supporters will be in a better position to support a youth worker at least half-time from 2009.

A thorough community survey was carried out two years ago and the feedback indicated a need for youth facilities and support. Local councillors and local police officers have visited the Café and discussed local needs and they are encouraging this application.

(iii) Applicant: Abingdon Concert Band, Abingdon

Years in existence: 30 years

Type of organisation: Club

**Project, service or event details:** Abingdon Concert Band is seeking a grant towards the purchase of a set of new banners which include its new logo to mark the band's 30<sup>th</sup> anniversary year. The existing banners are over 25 years old and showing obvious signs of wear and tear.

Abingdon Concert Band forms an important part of Abingdon's cultural activities with its distinct sound and musical repertoire, based on its mix of woodwind and brass instruments.

The band continues to go from strength to strength and has recently attracted new players and larger audiences. The existing members recognise the importance of recruiting young members into the band to secure the long term future of the band and its continued contribution to Abingdon's cultural life. They intend to build on this growth and maintain the appeal and viability of the band for the future by improving their image. The new banners will give the band a fresh, more professional and consistent identity and as such will play an important role in marketing the band and promoting their concerts and activities.

Abingdon Concert Band is pro-actively looking at ways to work better with other local organisations to promote the cultural life of Abingdon as witnessed by their joint concert at the Guildhall with Abingdon Town Band on 13 October which is expected to draw a capacity audience.

The new banners will be stored safely in a dedicated area at Dunmore Junior School and will be covered under the Band's insurance policy. It is anticipated that the banners will last for as long as the old ones.

Band membership costs £105 p.a. with a concessionary rate of £60 p.a.

#### (iv) Applicant: Abingdon Performance Arts Group Enterprise (APAGE)

Years in existence: 11 years

**Type of organisation:** Association of Arts Organisations in Abingdon and surrounding area; it organises the Abingdon Arts Festival by co-ordinating and publicising the individual events, sponsoring specific events such as the opening and closing events, and introducing new, speculative events.

**Project, service or event details:** APAGE is seeking a grant towards funding for the printing, design and distribution costs associated with the brochure for the Abingdon Arts Festival 2008 which will be held from 1-15 March. 19,000 copies will be printed and distributed to every house and business in Abingdon and the surrounding villages. Copies will also be placed in information points and libraries throughout the Vale. APAGE now has 10 years of success to build upon and is committed to continuing to hold an annual event.

At the meeting of the Abingdon Area Committee on 19 October 2006 when the last grant application from APAGE was considered, the Committee resolved that any future financial support from the Council will be dependent on the production and distribution of future brochures having been subject to a competitive tendering exercise. For the current application APAGE has tried to negotiate sponsorship of part of the printing costs with its chosen printer but has been unsuccessful. APAGE will now be undertaking a competitive tendering exercise similar to the exercises undertaken in the past where three tenders were sought from different local companies including a new company each year. The cheapest tender was the one accepted which has resulted in five different printing companies being used since the first festival.

(v) **Applicant:** Abingdon Festival Music Association

Years in existence: 10 Years

**Type of organisation:** Charity

Project, service or event details: Abingdon Festival Music Association is seeking a grant towards the costs of running a concerto class in 2008. The concerto class was introduced in 2005. Candidates perform a concerto movement accompanied by a professional pianist. Professional adjudicators select a winner to play in a public concert with the Abingdon Symphony Orchestra and two runners up play in an open rehearsal with the orchestra.

The enthusiasm generated at the first concerto class led the Abingdon Festival Music Association to repeat the venture in 2006. The two winners gave a stunning public performance of the Poulenc double piano concerto.

Although several local festivals offer a concerto class, only the Abingdon Festival Music Association is working in collaboration with the town's symphony orchestra and as a result is able to provide this unique opportunity for young people to perform with a symphony orchestra locally. The 2008 concerto class will be held at Radley College.

The Association's aim is to advance the education of the public in the Arts, and in particular the art of music. It intends to run the concerto class on a biennial basis, depending on the orchestra's programme needs.

#### Applicant: North East Abingdon Community Association (NEACA)

#### **Background**

On 25 May 2004 the Abingdon Area Committee considered a grant application from NEACA for a grant towards the cost of providing a multifunctional facility for educational and recreational use and awarded a grant of £50,000.

The application was also considered by the Executive on 4 June 2004 and an award of £25,000 was made from the Lottery and Other Grants Support Fund to help NEACA in its application to the Lottery for a major portion of the project funding.

As fundraising for a large-scale project can take several years, the project was divided into three phases. Phases I and II and part of Phase III have been carried out. Following the unsuccessful outcome of NEACA's Lottery bid, the Phase III extension was put on hold so that other funding could be raised and alternative solutions explored.

#### **Current situation**

After researching various options NEACA has decided not to proceed with an extension to the existing building but to go ahead with the construction of a log cabin produced by Cabinco and a refurbishment of the current facilities.

The log cabins are being used widely for the provision of community facilities and additional classrooms. They are purpose-designed, economic to build, heat and maintain. The log cabin can be made and delivered within eight weeks from the date of the order which would mean that, subject to planning permission being granted, the cabin could be built before the end of the financial year.

The refurbishment would include the installation of a new heating and ventilation system and bringing the existing hall up to modern standards in terms of décor, thus making it more attractive for the use of local residents on a daily basis. Previous use has been restricted due to pre-school activities.

The estimated cost is £230,000 for the purchase and installation of the cabin, the cabin furnishings, the new heating and ventilation system and refurbishment of the current hall.

The funding awarded to NEACA by the District Council has been accrued for three financial years as a result of the setbacks in fundraising. NEACA is still committed to achieving the original aims of the project, namely to provide the pre-school with dedicated and appropriate facilities; to engage young people in valuing their local facilities and area and reduce antisocial behaviour, to provide young people and the elderly with somewhere safe to meet, and to encourage understanding and acceptance between differing elements of the local population. There are clear benefits for the community if the project could be completed without further delay.
