Decision	To recommend that Vale of White Horse District Council makes the Faringdon Neighbourhood Plan part of the development plan for the district.				
Reasons for decision	The Neighbourhood Plan has followed the correct statutory process and this is the final step in its development. Faringdon Neighbourhood Plan was agreed through a local referendum held on 24 November 2016. A total number of 1,038 residents voted in the referendum. Of these, 944 residents voted in favour of the Neighbourhood Plan being made by the district council, 91 per cent of the turnout. The next step in the process is to consider making the Plan a part of the Development Plan for the Vale of White Horse and to recommend to Full Council that the Faringdon Neighbourhood Plan be adopted as a part of the Development Plan. Once adopted the Faringdon Neighbourhood Plan will form part of the statutory development plan for the district. Its policies will be relevant for the determination of planning				
Alternative options rejected	applications in Faringdon parish. More than half of people who voted, voted yes. The neighbourhood plan, including its preparation, does not breach, and would not otherwise be incompatible with, any EU obligation or any of the Convention rights (within the meaning of the Human Rights Act 1998). There are therefore no options open to the Council other than to make the plan part of the Development Plan.				

Legal implications	Paragraph 38A (4)(a) of the Planning and Compulsory Purchase Act 2004 requires that the district council must make the neighbourhood plan if more than half of those voting have voted in favour of the plan being used to help decide planning applications in the plan area. The district council are not subject to this duty if (and only if) the making of the plan would breach, or would otherwise be incompatible with, any EU obligation or any of the Convention rights (within the meaning of the Human Rights Act 1998).					
	It is not considered that the neighbourhood plan would breach, or would otherwise be incompatible with, any such obligation or rights. Therefore, and notwithstanding that a judicial review has been lodged challenging the council's decision to accept the modifications recommended by the examiner and to proceed to referendum (this legal challenge is centred around the inclusion in the plan of a policy or policies relating to Wicklesham Quarry and is currently at the 'application for permission' stage of judicial review), the council should now proceed to make the plan.
