# <u>SIMPLER APPROACH TO NEIGHBOURHOOD PLANNING PILOT – UPDATED</u> DELIVERY PLAN

#### **Background**

The Department for Levelling Up, Housing and Communities (DLUHC) invited South Oxfordshire and Vale of White Horse District Councils to take part in the Simpler Approach to Neighbourhood Planning Pilot.

The objective of this pilot is to test whether a simpler form of neighbourhood planning could empower more communities to play a direct role in shaping their neighbourhoods.

The Councils signed the Terms of Reference for taking part in the pilot on 14 February 2022. The pilot is expected to last for at least 12 months and the Councils are expected to work with at least 3 neighbourhood planning groups. The Councils are expected to take part in the Pilot alongside the following local authorities:

- Babergh and Mid Suffolk District Council
- Bassetlaw District Council
- Harborough district council
- Leeds City Council
- London Borough of Tower Hamlets
- Middlesbrough Council

The Councils have received £45,000 from DLUHC to support the delivery of the pilot. and are expected to provide DLUHC with a delivery plan, which includes:

- Details of the delivery team and key responsibilities
- Timeline for delivery including key milestones
- Details of the groups you propose to work with
- Allocation of funds









#### Timeline for delivery and key milestones

We have used the indicative process set out by DLUHC to help shape our approach. Engagement with our 6 pilot groups is expected to help refine it.



#### Where we are: Stage 3 - Building capacity

We will deliver a minimum of 18 hours of bespoke support to build capacity within the 6 pilot groups.







We have already held the intro meeting and delivered the first two capacity building workshops.

In response to the pilot groups request, we are going to deliver an additional workshop, where the district council and pilot groups can collaborate on the development of a template/agreed format for Neighbourhood Priority Statements, before we resume the delivery of the remaining two capacity building workshops outlined above.

We will use these workshops to give our pilot groups the best possible start. It will also be an opportunity to work collaboratively and identify innovative engagement methods and different ways of setting place-making priorities.

#### Next step: Stage 4 – Information gathering and statement drafting

During this stage the district council will offer one to one support with each pilot group having access to their designated lead officer. We will also facilitate regular discussions between the pilot groups so they can collaborate and share ideas.

#### **Expected outputs**

All pilot groups are committed to the preparation of a Neighbourhood Priority Statement. Early engagement indicates the ambitions of some groups may be better served through the preparation of a traditional neighbourhood plan and we believe some groups may take this additional step once they complete their participation in the pilot. In addition to these we expect the pilot will:

- Build capacity within the pilot groups through workshops with district council and regular discussion with other pilot groups.
- Deliver one to one support from the district council to pilot groups with a designated lead officer for each group.
- Develop a template to guide an agreed format for Neighbourhood Priority Statements.
- Help communities better understand their issues, opportunities and priorities.
- Provide qualitative date about what matters to communities and how detailed Neighbourhood Priority Statements should be.
- Fund community engagement and/or gathering information with the portion of funding allocated to pilot groups.

#### Details of the groups the Councils propose to work with

#### Selection process

The Councils invited applications from community groups between 4 March and 1 April 2022. Community groups across the districts were invited to apply to create a Local Placemaking Plan, as a simpler alternative to a Neighbourhood Plan. Information about

the pilot, including the expected scope of a Local Placemaking Plan and the expected process, was published on the Councils' websites and social media, and circulated via email. The communication material made clear we were aiming for a mix of groups from across the districts from both parished and unparished areas.

Seven community groups applied to take part in the pilot, all from parished areas. The Councils considered each application against the following criteria: how the pilot might benefit the area, how well the group would manage the workload, and how well the aims and expectations of the group aligned with the expected scope of the pilot output. A summary of this information is contained in Appendix 1. It should be noted that at the time we were aiming for a document that could potentially be adopted as a Supplementary Planning Document (SPD) and/or influence plan making. We will work with the pilot groups to explore how best we can adapt our project considering the concept of the process envisaged by DLUHC and information on Neighbourhood Priority Statements in the Levelling Up and Regeneration Bill.

#### Selected groups

The Councils selected Great Haseley Parish Council, Moulsford Parish Council and Stoke Row Parish Council in South Oxfordshire and West Challow Parish Council, Kennington Parish Council and Fyfield and Tubney Parish Council in the Vale of White Horse. The six selected applications broadly present opportunities for the preparation of documents that provide information regarding infrastructure, place-making and design and character. In some cases, we believe the pilot may build capacity and identify priorities for a potential future Neighbourhood Plan.



#### Allocation of funds



We will provide each group taking part in the pilot with up to £2,500 (from the pilot funding received by the councils), to ensure pilot groups have the resources and









freedom to test innovative approaches. We will work closely with the groups, support their ideas and monitor how they use the funding.

The councils will retain £30,000 to cover its costs associated with:

- Preparing and delivering capacity building workshops
- Providing guidance and assistance to pilot groups
- Coordinating communication and collaboration between pilot groups
- Helping develop processes
- Checking pilot outputs meet agreed standards
- Liaising with DLUHC
- Capturing lessons learnt and developing recommendations
