3.0 <u>Relationship with the Council's Vision, Strategies and Policies</u>

4.2 Since the last meeting of the Committee, the Council has been advised that the grant of $\pounds1,000$ awarded to the Wantage War Memorial Committee on 31 July 2007 is no longer required as sufficient funding was raised from other sources. This sum is therefore returned to the Committee's budget giving a total remaining budget for 2008/09 of $\pounds14,248$.
